The following NEW rules are being proposed: RULES 4759-10-01 to 4759-10-05

At this present time, every state agency, including OBD, is adopting rules regarding employees' use of confidential personal information in personal information systems. Section 1347.15 of the Revised Code, as enacted by Substitute House Bill 648 of the 127th General Assembly, requires every state agency to adopt these rules.

- 4759-10-01 Definitions.
- 4759-10-02 Procedures for accessing confidential personal information.
- 4759-10-03 Valid reasons for accessing confidential personal information.
- 4759-10-04 Confidentiality statutes.
- 4759-10-05 Restricting and logging access to confidential personal information in computerized personal information systems.
